BACKGROUND/PROPOSAL:

Having concluded the 2021 municipal general election cycle for the Summer Village of Nakamun Park, we say goodbye to some of our past councillors and welcome a new council for the 2021-2025 term.

It has been the practice of the municipality to offer a recognition of councillor service to anyone who has served on council at the end of their term. This is note established by policy and is therefore addressed directly by the council of the day. Administration would recommend consideration be given to Carleigh LeClair for her service as councillor and deputy mayor over the past council term. It is not typically the practice to extend the same recognition to any incumbent councillors.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

Following the 2017 election cycle retiring councillors received a commemorative plaque and were invited to attend a working supper with outgoing and incoming councillors. There was significant change during the 2017 election so the opportunity to have the share past knowledge and advice was a benefit.

Administration is certainly supportive a commemorative plaque and perhaps a gift card similar to other service recognitions awarded in the recent past. While a supper would be nice, it is completely at the discretion of Council on if they want to include same; if you do want to include a supper component you want to consider delaying it until post-summer to allow for easier scheduling.

Any costs for Council Recognition and Appreciation would fall under the Annual Operating Budget/Council Budget.

Muni 101, EOEP Summer Villages Training 2021

BACKGROUND/PROPOSAL:

Section 201 of the Municipal Government Act requires Administration to make the required councillor training (orientation training) available within 90 days of the councillor taking office. The training is to be offered to each councillor, even if they have previously taken it, and may be in one of several prescribed formats/delivery methods.

The common approach is to coordinate with one of the many training sessions conducted by the Elected Officials Education Program (EOEP) supported through the Association of Summer Villages of Alberta (ASVA) and Alberta Urban Municipalities Association (AUMA).

The schedule of upcoming (fall 2021) training sessions is attached, as well as some additional background on the courses and offerings.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The courses being held in fall 2021 – specifically to accommodate summer villages – are being offered via zoom and each of the two offerings includes four two-hour sessions each focusing on a given subject.

Administration is requesting that Council authorize attendance of councillors at either of these two offerings and directs councillors to provide their preference in dates to Administration for registration as soon as possible.

COSTS/SOURCE OF FUNDING (if applicable)

Any costs for orientation training would fall under the Annual Operating Budget/Council Budget. Just a note that the zoom option, while helpful for access will result in 4 half day remunerations for each councillors so the cost will be comparative to previous courses (which were two day inperson meetings plus travel and board). The registration cost of \$275/person is comparable to previous prices as well.

RECOMMENDED ACTION:

a) That Council authorize the attendance of councillors at their preference of first or second offering of the Elected Official Education Program training courses as provided, and that councillors should forward their preference in offerings as soon as possible so that Administration can arrange registration.

As summer villages hold their elections in the summer, the <u>Elected Officials Education Program</u> (EOEP) is hosting virtual offerings of <u>Munis 101</u> exclusively for summer villages in September. Registration will open in the coming month at a rate of \$275 per person.

The course covers the essential information councillors need to know to be effective municipal leaders and is a necessary step towards receiving a <u>Municipal Elected Leaders Certificate</u> (MELC).

Munis 101 is developed and delivered with the support of Municipal Affairs to help municipalities fulfill the Municipal Government Act Requirement to provide orientation following the election.

While the course is oriented for elected officials, CAOs are welcome to take the course so that they are aware what is being covered and can provide supplemental orientation on any municipal specific information.

BACKGROUND/PROPOSAL:

Ted MacDonald Park is a hub of activity in the community. It is also a secluded space and is a noted location for unauthorized activities and noise/parking violations during the busier months. It has been the topic of an increasing number of conversations with residents over the past year – particularly summer 2021.

Administration is introducing this matter for the consideration of Council. In particular, we want to have quick discussion on possible options that have been proposed to reduce unwanted/off-hour activity in the park and seek Council's direction on if they want to authorize the next steps in addressing those options (tendering for any improvements).

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The July 21st, 2021 agenda package will go out prior to the Annual Meeting, so there may be more discussion to add to this during the meeting, however some proposed solutions include:

- i. New Signage 3-5meters inside each access to the park, including no overnight parking, no unauthorized camping in the park or boat launch area and a reminder of noise restrictions/bylaws etc.
- ii. Solar powered tollgates, with timers, to allow for restricted vehicle access during off hours (say 12midnight to 6am, for example).
- iii. Installation of some additional lighting in the boat launch parking lot area (LED streetlight(s)).
- iv. Obtaining some additional CPO/RCMP or private security surveillance during the busy summer season.

I think there are some of these items that the Summer Village could do right away (this year) if they wanted – certainly, the signage and lighting are within reason. The tollgates are a better option than the manual locking gates discussed earlier but will need to confirm pricing before that discussion can go too far along. Extra CPO/RCMP hours are going to be tough to make work, but again all subject to pricing consideration – if we want to do anything there it would likely need to wait until 2022 for the new budget.



COSTS/SOURCE OF FUNDING (if applicable)

Administration will try gather some ballpark pricing to present during the meeting to see if the items are even within reason, but if Council wants to proceed the next steps would be to authorize the opening of a project and have Administration proceed with acquiring actual tender pricing to be considered at a subsequent meeting for final approval. At Council's discretion, any of the capital items above would qualify for capital grant funding (MSI-Capital) for purchase and installation.
