**RE: NOTICE OF NOMINATION DAY – GENERAL MUNICIPAL ELECTION 2025**

2025 is a municipal general election year in Alberta. Summer Villages are unique in that the *Local Authorities Elections Act* stipulates that summer villages hold their elections during the summer months and their Nomination Day occurs on a date determined by Council – with the election, if required, occurring 4 weeks after Nomination Day.

New for this election, candidates are required to submit their *Notice of Intent (Form 29)* before accepting campaign contributions or incurring campaign expenses. *Form 29* can be filed at any time at the Summer Village Office, 2317 Twp Rd 545, Lac Ste Anne County. Candidates must submit their *Nomination Paper and Candidate's Acceptance (Form 4)* and *Candidate Financial Information (Form 5)* on Nomination Day. These forms are available on the above-noted website, at the village office, or from the Municipal Affairs website.
